

# HELPING TO MAKE WESTERN ARIZONA HEALTHIER

At Havasu Regional Medical Center, our goal is to deliver the best healthcare available to the residents of the Western Arizona region. With your continued support and encouragement, we seek to improve the health of our community with the help of dedicated physicians, employees, volunteers and board members.

Delivering quality medical care close to home is the single most important contribution we make. Here are some of the other ways we contribute to the overall health and economic sustainability in the communities we serve.

#### More than \$5 million in capital improvements

In 2010, we added new equipment and made a number of quality improvements to our state-of-the-art facility including prostate seed software for radiation therapy, new respiratory therapy equipment, bedside patient monitors, medicine pumps and recliners for the Cancer Treatment Centre, medication dispensing system, lab testing equipment, orthopedic surgery equipment, cardiovascular surgery equipment and equipment for performing colonoscopy procedures.

In addition, we expanded parking facilities for the convenience of our patients and visitors. In fact, we invested more than \$5 million in our facility in 2010 which included technology replacement, information technology additions/ updates, and important facility upkeep and maintenance.

In 2011, HRMC is undergoing a \$9.5 million renovation and expansion of its Intensive Care Unit (ICU), a new Birthing Centre (OB), a Wound Care Centre and a dedicated Pediatric Unit. The Birthing Centre, which opened in May 2011, added 11,000 square feet to the east side of the main building and has eight patient rooms, ensuring each patient has a private room with more space for their family members. These specialized, larger rooms are used for all phases of delivering babies: labor, delivery, recovery and post-partum (LDRP). The renovation of the ICU will add six large, private post-operative Cardiovascular ICU rooms with state-of-the-art monitoring equipment with specialty-trained, multi-disciplinary care staff including, nurses, respiratory therapists, pharmacists and physical therapists. This will bring the total number of ICU rooms to 16. The newly renovated Pediatric Unit will be able to accommodate 10 pediatric patients.

#### Contributing to our local tax base

Last year, Havasu Regional Medical Center paid more than \$1.6 million in taxes to help support our city, county and state. This includes sales tax as well as property and other taxes. These dollars help maintain local schools, development of roads, recruitment of business and industry, and other vital community services.

### Helping those in need

Havasu Regional Medical Center provided over \$261.6 million in uncompensated care last year, which included the amounts not covered by Medicare and Medicaid. This amount includes more than \$8.5 million for charity care and bad debt, incurred as we served many people

without the financial resources to pay for basic health services.

### **Adding new physicians**

During the past year, Havasu Regional Medical Center added 33 new physicians to our highly respected medical staff, including specialists in emergency medicine, cardiology, radiology, internal medicine, pulmonology, hematology/ oncology, family practice, nephrology, pathology, anesthesiology and urology.


#### One of our community's major employers
